NEW PRODUCTS

INSTALLATIONS

CLAIMS

CBM Motorsports online store. To initiate the product warranty process if product was purchased through the CBM Motorsports on line store, the consumer must log in to their account and fill out an RMA form. Warranty claims will be rejected if the date of purchase cannot be established by the consumer.

CBM Motorsports ebay store. To initiate the product warranty process if product was purchased through the CBM Motorsports ebay store, the consumer must log in to their ebay account and follow the return an item procedure. Warranty claims will be rejected if the date of purchase cannot be established by the consumer.

CBM Motorsports Amazon store. To initiate the product warranty process if product was purchased through the CBM Motorsports Amazon store, the consumer must log in to their Amazon account and follow the return an item procedure.
